Includes (a) a deferred stock award of 10,335 restricted stock units which shall vest in four equal installments on January 1, 2016, 2017, 2018 and 2019; and (b) a deferred stock award of 11,247 restricted stock units with performance based vesting conditions, which shall vest on August 3, 2018 contingent upon achievement of a performance condition tied to relative total shareholder return.
